

# 2021 Capital Gains Distribution Estimates



Throughout the year, mutual funds may realize gains and losses from selling securities held in their portfolios. Tax laws require mutual funds to distribute the net gains from these sales to shareholders by year-end. To help with your 2021 tax planning, listed below are the capital gains distributions estimated to be payable from the Buffalo Funds, based on transactions posted through November 9, 2021.
