CORNERSTONES OF OUR INVESTMENT APPROACH

Higher Returns With Lower Risk

We invest in high yield bonds and non-investment grade bank loans that have the potential to generate high levels of current income and, secondarily, capital appreciation.

As a result of our credit intensive research, we tend to hold an overweight position in “B” rated securities relative to our peers. Our goal is to hold the issues we purchase until maturity. With our fundamental selection process, we favor publicly owned, small- and mid-sized companies that have experienced and disciplined management teams, generate positive free cash flow, strong balance sheets, and attractive asset coverage ratios. We generally do not invest in distressed securities or leveraged buy outs, which tend to be riskier, less liquid and less transparent.

We are pleased that the Fund has delivered impressive results over time. In fact, the Fund has top 20% performance for the 5-year period and Morningstar’s “Low” or “Below Average” Risk Rating for the 3-, 5- and 10-year periods, as of March 31, 2026.

A Focus on Downside Protection

With an emphasis on delivering attractive returns, we seek to provide investors with a “smoother ride” when investing in high yield securities. As such, our intensive credit research has enabled the Fund to have a historically significantly lower downside capture ratio compared to the Morningstar High Yield Bond category average.

The Morningstar Rating™ for funds, or "star rating," is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a 3-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating™ for a managed product is derived from a weighted average of the performance figures associated with its 3-, 5-, and 10-year (if applicable) Morningstar Rating™ metrics. The weights are: 100% 3-year rating for 36-59 months of total returns, 60% 5-year rating/40% 3-year rating for 60-119 months of total returns, and 50% 10-year rating/30% 5-year rating/20% 3-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent 3-year period actually has the greatest impact because it is included in all 3 rating periods. Morningstar Risk scores for a given time period (three, five, or 10 years) reflect the Fund's Morningstar risk score plotted on a bell curve: Monthly calculations are based on whether the Fund scores in the top 10% of its category, its risk score is considered High; if it falls in the next 22.5% Above Average; a place in the middle 35% is Average; those lower still, in the next 22.5%, are Below Average and the bottom 10%. Overall Morningstar risk score is a weighted average of the available three, five, and 10 year Morningstar risk scores. Investments with less than three years of performance history are not rated.

The ICE BofA U.S. High Yield Index is an unmanaged index that tracks the performance of U.S. dollar denominated, below investment-grade rated corporate debt publicly issued in the U.S. domestic market. One cannot invest directly in an index.

Free cash flow is a measure of the cash produced by the firm in a given period on behalf of equity holders. The true measure of the value of a firm's equity is considered to be the present value of all free cash flows. Downside capture is used to evaluate how well or poorly an investment manager performed relative to an index during periods when that index has dropped. An investment manager who has a downside capture less than 100 has outperformed the index during the down-market. For example, a manager with downside capture of 80 indicates the manager's portfolio declined only 80% as much as the index during the period in question. Sharpe ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk.
